## Tier I Canada Research Chair in Statistics and Actuarial Science and CANSSI Scientific Director

## Department of Statistics and Actuarial Science Simon Fraser University

The <u>Department of Statistics and Actuarial Science at Simon Fraser University</u> (SFU), in partnership with the <u>Canadian Statistical Sciences Institute</u> (CANSSI), is seeking applications for a faculty member at the rank of Professor, who will serve as the Scientific Director of CANSSI. The appointment as Scientific Director is for a fiveyear term. The appointee will be nominated for a Tier 1 Canada Research Chair.

SFU, partnering with the University of British Columbia (UBC), has recently led an initiative to establish CANSSI's first national headquarters at SFU's Burnaby Campus. We seek a dynamic individual with abundant energy and strong interpersonal and administrative skills who will lead the start-up of the new headquarters and further the Institute's mission to promote statistical sciences research and training both in Canada and internationally. The position will be held in conjunction with a Tier I Canada Research Chair (CRC) within the Department of Statistics and Actuarial Science. This initiative is part of SFU's strategic commitment to big data and more generally to data sciences, and The new CANSSI headquarters will be a cornerstone of the 25,000 square-foot Big Data Hub on SFU's Burnaby Campus. Accordingly, candidates should be researchers in the statistical sciences with high international stature and have an outstanding active research program. This Tier 1 CRC is tenable for seven years and may be renewed for a second term. Interested applicants are invited to review the initial appointment and chair renewal <u>details of the CRC Program</u>.

As an SFU faculty member and CRC, the successful candidate will be responsible for maintaining an active research program, teaching a range of undergraduate or graduate courses in statistics, engaging in research supervision, and participating in department, University, and professional service. For the term as CANSSI Scientific Director, teaching and service responsibilities will be significantly reduced.

As CANSSI Scientific Director, the successful candidate will be responsible for the scientific leadership and overall operation of CANSSI. The Scientific Director serves a 5-year term and reports to the Board of Directors of CANSSI. The duties include overseeing CANSSI headquarters at SFU's Burnaby campus; implementing CANSSI's Strategic Plan; enhancing research partnerships within Canada and with groups throughout the world supporting education, training and communication in the statistical sciences; and exploring new opportunities for growth and funding.

Launched in November 2012, CANSSI is the national institute that advances the development, application, and communication of cutting-edge statistical and data

science research and training. CANSSI builds multi-disciplinary collaborations with leadership in statistical science and data science and facilitates new linkages among researchers in academia, industry and government. CANSSI receives its major funding from the Natural Sciences and Engineering Research Council. CANSSI as a national not for profit corporation is accountable to its funders and to its institutional members. Originally a virtual institute, CANSSI will establish its physical headquarters on SFU's main campus in the fall of 2018.

SFU's main campus is located in Burnaby, BC, a suburb of Vancouver. The campus sits atop a forested mountain in a region renowned for its scenic beauty. The Department of Statistics and Actuarial Science has 23 faculty members and roughly 60 graduate students. SFU is defined by its dynamic integration of innovative education, cutting-edge research, and far-reaching community engagement. The metropolitan area offers tremendous opportunity for outdoor activities, as well as unparalleled cultural diversity. Vancouver is perennially listed among the world's most livable cities.

To apply, applicants should provide a letter of application addressing the qualities above; a full CV including details of research and teaching, scholarly record, funding, and list of collaborations/partnerships; and names and e-mail addresses of 4-5 referees. Review of applications will begin on October 15, 2018, and continue until the position is filled.
